Budget Boost Calls for Celebration and Caution

The state's 2018 fiscal year ended Sep. 30, exceeding expectations and greatly surpassing revenues needed to meet \$6.47 billion in education budget appropriations. While the state had relied on a growth rate of some 3 percent, the year ended with more than double that growth at 6.7 percent, bringing in \$336 million more in revenue than expected and appropriated. That's a stark contrast to just one year ago when the education community collectively held its breath as revenues barely met appropriations.

State revenue growth is subject to the Rolling Reserve Act, and the state will deposit \$64.2 million to bring the Budget Stabilization Account (BSA) balance to \$242 million. The Rolling Reserve Act requires up to 1 percent of any additional revenues collected above the prior year's budget be deposited in the BSA until it reaches 7.5 percent of the previous year's ETF appropriations. Those dollars are intended to be used in the event of proration. Any dollars above that threshold flow to the Advancement and Technology Fund (ATF). Lawmakers may appropriate, through separate legislation, ATF funds to local school systems to use in the current budget. That means an additional \$272 million will be available to K-12 and higher education this fiscal year. Those monies may be spent on any of the following: repairs and deferred maintenance; classroom instructional support; insurance for facilities; transportation; the acquisition or purchase of technology; or school safety. Public education received a \$53 million bump through the ATF fund in the fiscal year that just ended.

These impressive numbers mean an unexpected boost this year and a strong projection for the FY20 ETF budget lawmakers will craft in the 2019 Regular Legislative Session beginning March 5. Reports indicate the FY20 education budget may crest to more than \$7 billion, a first for Alabama. This boost is cause for both celebration and caution, as the state's ability to sustain such revenue and growth in coming years is a concern. Lawmakers will be asked to consider that dollars spent on recurring expenses must be sustained. It is said that lawmakers have it hardest when there are more dollars available because so many will come forward with funding requests. It appears a minimum of

\$300 million — and likely a lot more — in new dollars will be available to spend. Expect the legislative quadrennium to start with a bang.
