The audience was packed for Thursday's State Board of Education meeting, as Alabama's 2019-2020 Teacher of the Year Ana Carolina Behel, Teacher of the Year Alternate Jacque Middleton and 14 district finalists were recognized. The meeting agenda was light on action items, with most of the meeting devoted to recognizing educators.

In a carryover from the April meeting, the board approved Lt. Gov. Will Ainsworth's Alabama Public Charter School Commission nominee, Allison Hagood, with four yes votes and three abstentions. The board also announced its intent to adopt changes to the Alabama Administrative Code pertaining to student health services, specifically regarding the Alex Hoover Palliative and End-of-Life Care Act, appointed the 2019-20 k-12 textbook committee for health, and approved educator preparation programs for Alabama A&M University.

Near the end of Thursday's meeting, the board received results of the early performance evaluation of State Superintendent Dr. Eric Mackey. Gov. Kay Ivey's Education Policy Advisor Nick Moore explained how the results were compiled and tabulated. Mackey's evaluation covered six categories, and he received a composite score of 3.67 on a five-point scale, with his highest score (4.41) in "personal qualities" and lowest (3.32) in "performance and key job responsibilities." Individual board member composite scores ranged from a 1 from Ella Bell (District 5) to a 4.61 from Jeff Newman (District 7). Board Vice President Dr. Cynthia McCarty (District 6) said Mackey will use the recommendations as constructive guidance to provide the board with a personal professional growth plan. During a brief superintendent's report, Mackey addressed a large contingency of students from Washington County, assuring them that he and members of the state board are listening to their concerns about a proposed charter school in their community. He stressed several times that he couldn't "say much more "

The work session following the meeting featured several lengthy presentations, the first led by Tommy Glasscock, assistant state superintendent, Career and Technical Education/ Workforce Development Division. A large group of CTE representatives from more than a dozen Alabama school systems were on hand to hear Glasscock explain how the ALSDE is working to address challenges with CTE educator certification. Problems arose when the company that provided the previous basic skills assessment disbanded and the department defaulted to the same assessment used for college students. While most passed, many had trouble with the higher-level assessment. Glasscock said the department has worked with ACT on a comprehensive study to develop an assessment that more accurately reflects needed skills for CTE educators, including applied math, workplace documents and business writing. In addition, beginning with the 2019-20 year, those enrolled in the CTE Teacher Certification Program will receive targeted professional development to assist in improving the retention rate. Because the plans addressing CTE certification and retention do not involve an administrative code change, it could be adopted at the next board meeting. View CTE presentation.

Deputy State Superintendent Dr. Daniel Boyd updated the board on several issues, including the department's efforts to improve outcomes in specialized treatment centers (STCs) which serve approximately 2,000 students referred from DHR, the court system and other entities. He said a meeting regarding STCs will take place May 22, facilitated by a representative of the American Institutes for Research with several STC experts in attendance. Boyd also discussed steps the department is taking to attract new teachers, which he said is becoming even more difficult because of a booming economy full of competition from business and industry sectors. Those strategies include changes to Alternative Certification requirements that would allow a GPA of 2.0 with a higher Praxis score. For provisional certificates, the current "recency" rule requiring candidates to have completed a degree within the last five years will be removed. In addition, the basic skills assessment will no longer be required for candidates who possess a bachelor's dearee.

Boyd also informed the board of the Teacher Shortage Task Force's recommendation to

raise the pass score for the math Praxis. A discussion followed about the lack of consistency in graduation requirements among colleges of education, with some having a Praxis pass requirement to earn an education degree, some requiring students to pass the Praxis before entering student teaching and others having no Praxis score requirement for graduation. McCarty said she would like to see data comparing the Praxis processes and teacher success.

In an assessment update, Assistant State Superintendent of Education Dr. Tony Thacker told the board the assessment task force has recommended sticking with the ACT as the high school assessment. He also said about 150,000 students have completed pilot testing of the new DRC-developed assessment for grades 2 – 8. Another presentation by Assistant State Superintendent of Education Dr. Elisabeth Davis focused on <u>structured literacy and</u> <u>dyslexia support updates</u>.

**Next State Board Meeting:** The next State Board of Education meeting will take place June 13 in Montgomery at 10 a.m., followed by a work session.

# Alabama Charter Commission Meeting Update

The Alabama Charter Commission met by teleconference on April 29, 2019. The Commission discussed the following items and took the following actions:

- Approved a resolution to formally approve the i3 Academy (Birmingham);
- Extensively discussed proposed changes proposed by Legacy Prep (Birmingham) relating to its budget, funding and enrollment expectations. The Commission tabled the proposal and requested additional information be provided;
- Discussed the Commission's expectations for the schools opening this fall, including Legacy Prep (Birmingham), Woodland Prep (Washington County) and LEAD Academy (Montgomery);
- Approved University Charter's (Sumter County) submission regarding growth measurements;
- Discussed Commissioners up for reappointment when current terms end on May 31;
- Discussed Woodland Prep (Washington County), recent media interest and strategies to share more factual information.
