


SBOE Discusses PCG Report, FY21 Budget

The State Board of Education discussed findings from an operational review of the Alabama State Department of Education during its virtual work session Thursday. The review was commissioned last year by the Alabama Legislature, which provided \$750,000 from the FY20 Education Trust Fund (ETF) budget to the State Examiners of Public Accounts along with a charge to launch an RFP for the work. Through the RFP process, the Public Consulting Group (PCG) was engaged to conduct the review.

PCG project leaders provided the board with an overview of the work they conducted between October 2019 and March 2020, including stakeholder interviews and document reviews. PCG's final report outlines a host of recommendations to improve ALSDE policies, functions, programs, funding and organizational structure. The work session overview focused on five key recommendations included in PCG's executive summary.

Also during the work session, board members reviewed a spreadsheet for the FY21 budget request which inlcudes increases for key ALSDE priorities.


Title IX & Athletics | JUNE 24 | Noon to 1 p.m.
