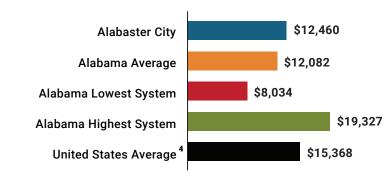

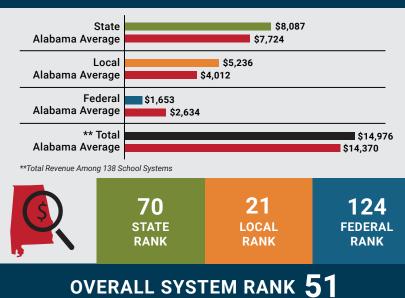

Per-Pupil Revenue Sources

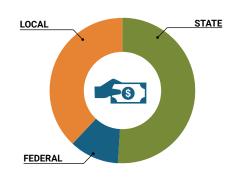
Alabaster City Revenue Sources

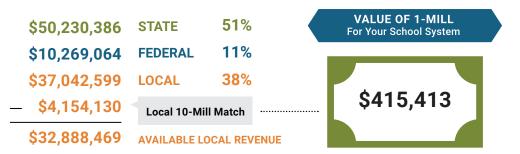
