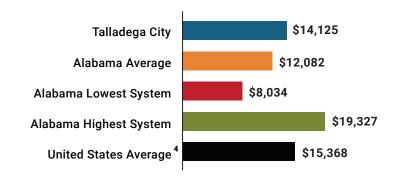

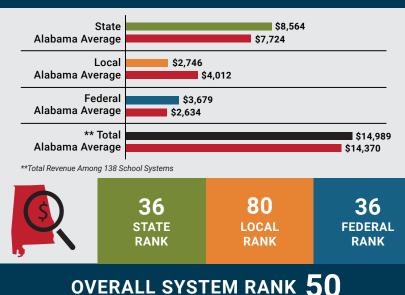

# **Per-Pupil Revenue Sources**

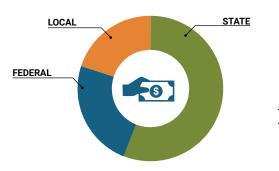
#### **Talladega City Revenue Sources**

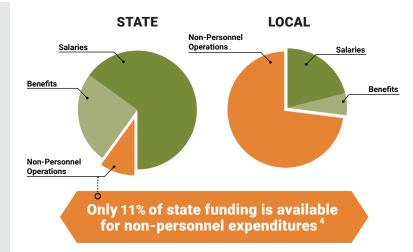
