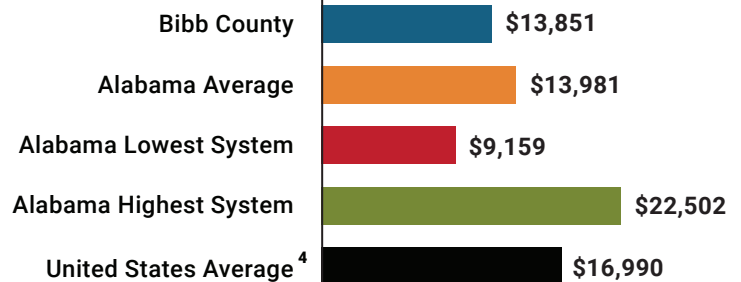

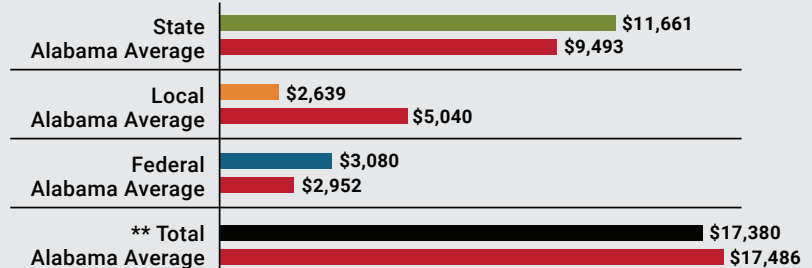

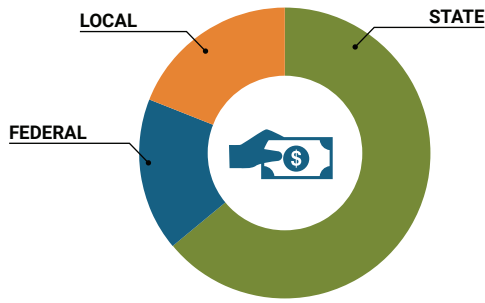
## OVERALL SYSTEM RANK 72

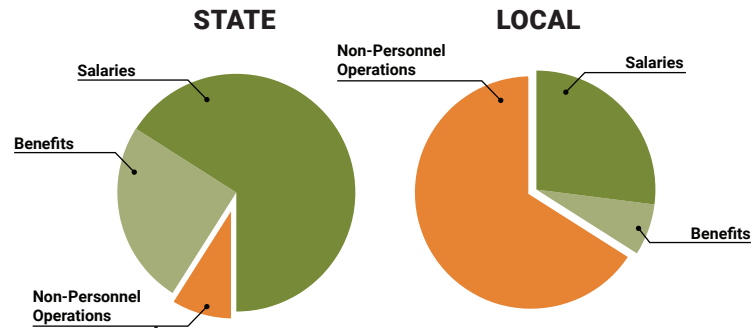

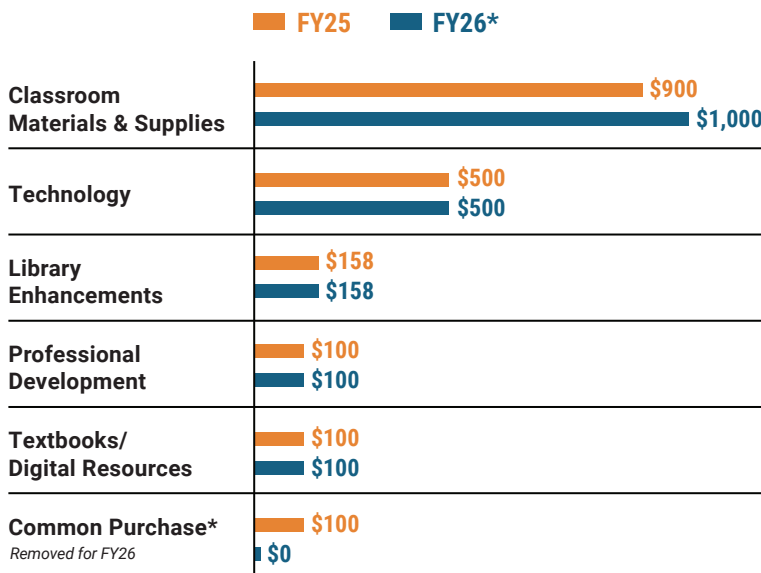

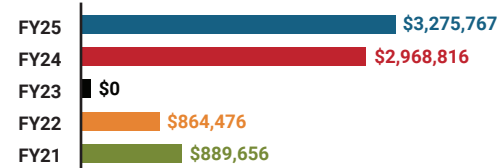
