# State Board Extends Mackey's Contract, Discusses Federal Funding Concerns

The Alabama State Board of Education voted 7-1 to approve a revised contract for State Superintendent Eric Mackey, extending his tenure through 2029 with a \$35,000 raise. The approved salary of \$325,000 represents a reduction from the initially proposed \$90,000 increase that had drawn public scrutiny. Following the vote, Board Vice President Dr. Tonya Chestnut called for establishing comprehensive written guidelines for future contract processes to improve consistency and transparency.

Mackey detailed challenges with recently canceled federal ESSER funds affecting Selma's tornado-delayed school construction and the state's reading initiatives for struggling students. He also reported on U.S. Department of Education correspondence regarding Title VI civil rights assurances that warns schools implementing certain Diversity, Equity and Inclusion (DEI) programs could risk losing federal funding.

Other meeting highlights included:

- Recognition of Jefferson County Schools Superintendent Dr. Walter Gonsoulin as the 2025 National Superintendent of the Year—the first Alabama superintendent to receive this honor
- Honoring Mary Travis, a fifth-grade math teacher from Mobile County Schools, as Alabama's sole recipient of the prestigious 2024-2025 Milken Educator Award
- Approval of Praxis assessment cut scores for teacher certification and textbook
  committees for Arts and Social Studies
- Celebration of Alabama's Purple Star Schools supporting military-connected students
- Discussion of educator preparation programs from Auburn University Montgomery (visual impairment) and Huntington College (rural education

initiatives)

#### DID YOU KNOW?

- **Incoming Board Members:** Even if they have not yet taken office, your incoming board members are already eligible to participate in board member training at board expense. (See AG Opinion).
- **Superintendent Discount:** Superintendents attending orientation with their new board members receive a \$20 discount off the price of registration.

The School Board Governance Improvement Act requires all new board members to take an Orientation covering mandated topics within one year of the July 1 after taking office.
