# SBOE Approves New Teacher Certification Options to Address Shortage

The Alabama State Board of Education (SBOE) approved significant changes to teacher certification requirements to help address the teacher shortage facing many Alabama school systems are facing in certain subject areas and geographical locations. The board also approved an amendment adding a sunset provision of two years, with the changes expiring June 30, 2024.

Currently, the state requires prospective teachers pass the Praxis teacher assessment in their subject area, maintain a 2.5 GPA and pass the edTPA assessment to receive a professional educator certificate. Now, students who are close to passing the Praxis will have additional options to pursue certification.
