State Board Approves Dallas County Schools Intervention, Discusses Changes at USDOE

The Alabama State Board of Education (SBOE) voted unanimously Thursday to approve state intervention into Dallas County Schools due to financial management concerns. This makes Dallas County the third Alabama school system under state intervention, alongside Sumter County and Bessemer City Schools. Dr. Daniel Boyd will serve as chief academic officer for Dallas County Schools, the same role he holds in Bessemer City.

In legislative updates, the Alabama State Department of Education (ALSDE) is pursuing legislation to expand the state's intervention authority, including a five-year provisional release period. The Board also approved comprehensive changes to the Educator Preparation Programs chapter of the Administrative Code to align with the Alabama Numeracy Act and increase field experience for teacher candidates.

Superintendent Eric Mackey provided an update on the U.S. Department of Education's recent staff cuts of approximately 1,300 employees, though no program cuts have been announced and Alabama's federal education funding remains unaffected. About 10% of Alabama's K-12 education funding comes from federal sources, primarily for special education and Title programs.

In other board news, Jefferson County Schools Superintendent Walter Gonsoulin will be formally recognized as the National Superintendent of the Year at the SBOE's April 10 meeting. He is the first Alabama superintendent to receive this honor. The SBOE also discussed the renewal of Superintendent Mackey's contract for another four years through 2029.


