### ALSDE support often begins with the classroom environment...

- **Establishing Clear Expectations**: Setting clear expectations helps students understand what behavior is acceptable and what is not, creating a stable environment for learning.
- **Building Positive Relationships**: Positive relationships between teachers and students foster a supportive learning environment, encouraging engagement and contribution.
- **Creating a Structured Environment**: A well-organized classroom minimizes distractions and maximizes focus, with designated learning zones and consistent routines.
- Implementing Engaging Lessons: Engaging lessons capture students' attention and encourage active participation, keeping them actively involved in learning.





### Behavior Supports are Tiered...Just Like Academic Supports

**Tier I:** Strong school values and policies, as well as healthy classroom practices (all students)

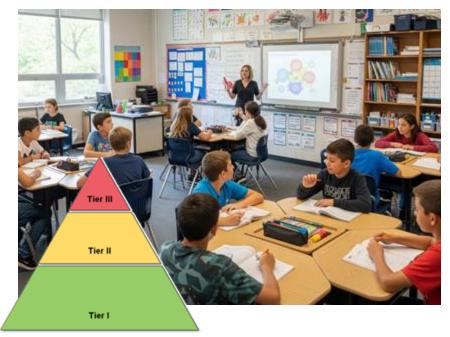
 Ex. Schoolwide Systems, Stakeholder Input, Training for Students, Faculty, and Parents, Similar Classroom Systems

**Tier II:** Targeted support to groups of students that need alternative strategies to support their behavioral success (subset of students)

 Ex. Behavior Contract, Break Passes, Check-In/Check-Out Process

**Tier III:** Individualized support (student-specific)

Ex. Individualized Behavior Improvement Plan (BIP),
Counseling, Modified Schedule, Functional Behavior Plan

# **Embedded Content and Coaching Supports**

Classroom management is not a standalone responsibility- it's a reflection of system alignment.

#### **Instructional Planning Support**

Guidance on implementing engaging, evidence-based classroom practices.

#### **Student Readiness Assessments**

Tools to evaluate developmental maturity and self-regulation in Grade 1.

#### **Tailored Coaching and Professional Development**

Support designed to meet educators and schools where they are in their journey.

#### **Classroom Environment Stabilization**

Assistance in establishing routines, norms, and a positive learning climate.

#### **Family and Community Engagement**

Development of structures that foster strong partnerships with parents and families

#### **Laws and Structures**

Implement current laws to support classroom management inclusive of the *Focus Act*, Continuous Improvement Plans, Mental Health Service Coordinators, etc.



### **Special Education Supports**

- The Special Education Section supports LEAs with creating a positive classroom environment in an effort to increase student engagement and reduce the likelihood of challenging behavior.
- Support is provided to those that have existing issues; however, the main focus is centered around professional learning to prevent discipline issues. As a result, training is geared toward disability-related behaviors.
- Training is provided on use of High-Leverage Practices. Topics include, but are not limited to the following:
  - Establishing a Consistent, Organized, Respectful Learning Environment
  - o Providing Positive and Constructive Feedback to Guide Learning and Behavior
  - Teaching Social Behaviors
  - Strategies and Tips for Teaching Self-Regulation
  - Using Explicit Instruction
    - Strategies to Promote Active Engagement



# **Special Education Supports**

- At times additional support is needed through qualified specialist.
- As it relates to behavior, grants are provided to LEAs for a Board Certified Behavior Analyst (BCBA®) or Board Certified Assistant Behavior Analyst® (BCaBA®) to support behavioral services to a student with a disability, ages 3-21.
- Last fiscal year, 113 LEAs received funds for this purpose.
- In addition, other funds are available through Special Education supplemental funding sources.
