## SBOE Announces Teacher of the Year, Discusses Assessments and Superintendent Evaluation

The Alabama State Board of Education announced Dr. Andrew Jackson, a fourth-grade teacher at Pell City's Eden Elementary School, as Alabama's 2020-2021 Teacher of the Year at its meeting Thursday, August 13. David Dai, a secondary school teacher at Alma Bryant High School (Mobile County Schools), was named Alternate Teacher of the Year. This year's virtual announcement via candidate videos took the place of the usual Teacher of the Year reception due COVID-19 safety precautions.

The work session following Thursday's meeting included presentations and discussions on student assessments, the superintendent's evaluation, the ALSDE's FY21 proposed budget and more.

**UPDATE:** The original deadline for the contest was April 13, 2020; however, due to school closures caused by the COVID-19 pandemic, the deadline will be extended through the fall. **The new contest deadline** is Oct. 21, 2020.

This year's contest theme, "Road to Success," applauds excellence in teaching, student creativity and how Alabama's public schools are preparing students for many

different pathways to success, from career technical education to STEM to advanced academics, performing arts and more! A maximum of two entries will be accepted from each Alabama school system.

Four lucky schools will share in more than \$3,000 in prize money for their 30- to 60-second commercials/public service announcements. The top four videos will be shown December 5, 2020, during AASB's Annual Convention at the Hyatt Regency Birmingham-The Wynfrey Hotel and at a future Alabama State Board of Education meeting in Montgomery.

### September Webinar: Students & The First Amendment



#### **President-Elect Nominations**

AASB is seeking self-nominations for President-Elect. The President-Elect will serve a one-year term. According to AASB's bylaws, candidates for election to an elective office must have served on the AASB Board Nomination forms have been mailed and are due to AASB's executive director by Sept.

1. Ballots listing eligible nominees will be mailed to district members by Oct. 1. Each board within a district gets one vote. The board president will certify that action was taken at a board meeting to choose a candidate, and the ballot must be returned to AASB by Oct. 31. If only one person is nominated, he or she automatically becomes district director.
