SBOE Urges Improvements to Textbook Selection Process

State Board of Education members insisted during Thursday's work session the state continue working to ensure its mathematics textbook selection process better serves local school systems. Board members stressed that providing school personnel with clear, accurate information to help select the best quality mathematics instructional materials is paramount.

Board members have raised objections during recent meetings to a state list that currently includes textbooks scored with "weak alignment" to state standards. Board Vice President Jackie Ziegler (District 1) said local school systems should be assured that any textbook on an approved state list is of the highest quality. Months of discussions resulted in a request for a revised and expanded scoring rubric and timeline, requiring the Math Textbook Committee to regroup last month to apply the more robust rubric.

Other board meeting and work session news included a dicussion about the merits of requiring students to complete the Free Application for Federal Student Aid (FAFSA) as a criteria for graduation and an update on the Alabama Literacy Act and concerns about pandemic-related learning loss that could impact assessment scores.

Joint Advisory Issued on K-12 Cyber Threats

Cyber criminals view schools as targets of opportunity, and attacks on k-12 distance learning education have been a major concern for school systems nationwide during the COVID-19 pandemic.

The Federal Bureau of Investigation (FBI), Cybersecurity and Infrastructure Security Agency (CISA), and the Multi-State Information Sharing and Analysis Center (MS-ISAC) yesterday released a joint advisory on malicious cyber actors targeting kindergarten through K-12 educational institutions to cause disruptions and steal data.

Reminder: FCPA Report Deadline Jan. 31

Elected school board members and elected superintendents have unitl Jan. 31 to file their annual Fair Campaign Practices Act reports. The report, which details contributions to and expenditures by elected officials and candidates in 2020, is available through the Alabama Secretary of State's Office and local probate judges' offices and can be downloaded from the Secretary of State's website. In addition, anyone who ran for public office in 2020 and has not yet dissolved his or her election committee must file a report. Local officials should file with their probate judge; state officials file with the Secretary of State.
