SBOE Discusses Student Assessments, Previews FY22 Budget Request

The Alabama State Board of Education's Sept. 10 work session featured a lengthy discussion regarding student assessments for the current academic year. State Superintendent Dr. Eric Mackey told board members he received a letter from U.S. Secretary of Education Betsy DeVos saying she does not anticipate waiving federal assessments for this school year. Mackey added that no decisions have been made about whether this year's assessments will be used for accountability purposes. ALSDE staff also explained scaled down plans for administering the National Assessment of Education Progress (NAEP) test to roughly 1,700 fourth and eighthgrade students in more than 50 Alabama school systems.

The SBOE also received a preview of the FY22 budget proposal, which includes requests for \$411 million in increased funding over FY21. While the funding request overlaps with the boards' vision and strategic plan priorities, Mackey assured board members changes can be made moving forward through the process, especially because of the many unknown circumstances related to COVID-19. Board members emphasized that local school systems must have state funding support for any mandated programs. The FY22 budget proposal must be voted on at the board's October meeting and submitted to Gov. Kay Ivey by Nov. 1.
